1. Only those firms which in their individual capacity, satisfy the following criteria, need to quote for this tender.
2. The bidders will be responsible for effecting supply to the entire satisfaction of the undersigned or his authorized representatives. In case any defect in the item supplied is noticed, such item will be rejected at the risk and cost of the Supplier.
3. Bidders should have valid GST registration.
4. Bidders should have PAN allotted to him by the IT Department

5. Bidder shall not be blacklisted by any government agencies.

III. Other Terms and Conditions:

1. The undersigned does not bind himself to accept the lowest bid offer and reserves himself the rights of accepting the whole or any part of the tender and the bidder shall be bound to supply the accepted items at the rates quoted.
2. No advance payment will be made against supplies.
3. **The rate quoted by the bidder shall be inclusive of all (applicable taxes, transportation charges and delivery charges at site, etc. shall be stated invariably)**
4. Rates quoted by the bidder shall be valid for a period of six months from the date of opening of the tender.
5. Delivery period shall be specifically indicated in the supply order and shall be strictly adhered to. In general the supply shall be arranged within **3 days** on receipt of the confirmed supply order. Any delay in the delivery after placing the supply order may result in cancellation of the supply order or payment of liquidated damages @ ½% per day of the value of the supply order subject to a maximum of 10% of the price of the supply order.
6. The rate should be quoted for the unit shown in the list and bid offers which do not indicate this essential information will not be considered.
7. The rate quoted for material shall be firm and no enhancement will be allowed under any circumstances during the period of the contract.
8. If the bidder furnishes wrong and/or misleading data, statement(s) etc. about technical acceptability of the goods and services offered by it, its tender is liable to be ignored/ rejected in addition to other remedies available to the purchaser in this regard.
9. items offered shall conform in all respects to the relevant Indian Standard Specifications.
10. Any dispute / difference between the parties arising out of and in connection with the contract shall be settled amicably by mutual negotiations.
