### Specification for Wooden Chemical shelf

**Required quantity - 1 Nos**

1	Size of shelf is 78 inch Height (including 5 inch leg) x 54 inch Width x 24 inch depth. Total 4 nos of horizontal compartments in equal divided measurements. Bottom portion wooden and chemical keeping place and balance 3 compartments fixed in Aluminium grill fixing in wooden support. Two number openable shutter with lock and key facilities. Shutter made with wood and glass. Made with chemically treated rub wood 18 mm/12 mm board. Each unit portions are undergone a special polishing process including three coats of sanding sealer with proper sand papering for obtaining even and smooth surface than one coats of clear PU (exterior grade) spray polish finish.

### Terms & Conditions
