prescribed in the notification before applying for the post.

2. Qualification degrees wherever specified should be obtained from recognised universities or Government /industry recognised institutes. Age, qualification and experience possessed by the applicant **as on the closing date** of the notification only will be considered. Applicants shall clearly specify the details and provide supporting documents. Relaxation in age or number of years of experience may be considered in the case of exceptionally deserving candidates with proven expertise in the relevant domains specified in the notification, at the discretion of C-DIT.
3. Remuneration will be fixed suitably in the range specified, depending on the qualification and experience of the candidate.
4. Application prepared in the enclosed format shall be submitted /forwarded in sealed envelope to the office of the Registrar, C-DIT, Chitranjali Hills, Thiruvallam, Tvpm -27 by post or directly with documents to prove age, qualification and experience so as to reach his office before the closing date. The envelope shall be superscribed with "Application for Consultant (Internal Audit)". Incomplete applications will be rejected. Acceptance or rejection of applications will be at the sole discretion of C-DIT and will be binding on the applicant.
5. Original certificates shall be submitted for verification at the time of joining. If any discrepancy is found in the application and documents, the offer letter shall be cancelled and the applicants will be disqualified. It will be the sole responsibility of the applicant to produce original documents for verification of their claims, whenever called for.
6. The mere possession of the prescribed qualifications or the number of years of experience, will not entitle any applicant to be considered for appointment. Only those applicants who have demonstrable expertise/experience in the areas mentioned and/or similar areas, will be considered for selection, at the sole discretion of C-DIT.
